Specific Hazards Arising from the Product

Special Protective Equipment and Precautions for Fire-fighters

Evacuate area. Fight fire from a protected, explosion-resistant location or maximum distance possible. Approach fire from upwind to avoid hazardous vapours or gases. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.
