Inhalation

Extinguishing Media

Suitable Extinguishing Media

Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog. Special "alcohol resistant fire-fighting foams". Use water to keep non-leaking, fire-exposed containers cool.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour.

In a fire, the following hazardous materials may be generated: corrosive, flammable ammonia; very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a protected, explosion-resistant location or maximum distance possible. Approach fire from upwind to avoid hazardous vapours or gases. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles. Dike and recover contaminated water for appropriate disposal.

Chemical protective clothing (e.g. chemical splash suit) and positive pressure SCBA may be necessary.

Personal Precautions, Protective Equipment, and Emergency Procedures
