SECTION 4. FIRST-AID MEASURES

First-aid Measures

Inhalation

Move to fresh air. If breathing has stopped, trained personnel should begin rescue breathing. Seek immediate medical attention.

Skin Contact

Immediately wash gently and thoroughly with lukewarm, gently flowing water and mild soap for 15-20 minutes. Immediately call a Poison Centre or doctor.

Eye Contact
