First-aid Measures

Inhalation

Remove source of exposure or move to fresh air. Keep at rest in a position comfortable for breathing. If experiencing respiratory symptoms (e.g. coughing, shortness of breath, wheezing), call a Poison Centre or doctor.

SECTION 5. FIRE-FIGHTING MEASURES

Extinguishing Media

Suitable Extinguishing Media

Not combustible. Use extinguishing agent suitable for surrounding fire. Use water to keep non-leaking, fire-exposed containers cool.

Unsuitable Extinguishing Media

Specific Hazards Arising from the Product

Heating increases the release of toxic vapour. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. Approach fire from upwind to avoid hazardous vapours or gases. Dust explosion hazard. Use water spray or fog to prevent dust formation and minimize risk of explosion. Knock down vapours or gases with water fog or fine water spray. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

Fire-fighters may enter the area if positive pressure SCBA and full Bunker Gear is worn.

SECTION 6. ACCIDENTAL RELEASE MEASURES

Personal Precautions, Protective Equipment, and Emergency Procedures

Use the personal protective equipment recommended in Section 8 of this safety data sheet. Increase ventilation to area or move leaking container to a well-ventilated and secure area. Remove or isolate incompatible materials as well as other hazardous materials. Eliminate all ignition sources if safe to do so.
