Carbon dioxide, dry chemical powder, appropriate foam, water spray or fog.

Specific Hazards Arising from the Product

Combustible dust. May form combustible dust concentration in air. Closed containers may rupture violently when heated releasing contents.

In a fire, the following hazardous materials may be generated: very toxic carbon monoxide, carbon dioxide. Sodium Oxides.

Special Protective Equipment and Precautions for Fire-fighters

Fight fire from a safe distance or a protected location. Knock down vapours or gases with water fog or fine water spray. Dust explosion hazard. Use water spray or fog to prevent dust formation and minimize risk of explosion. For a massive fire, immediately evacuate the area and use unmanned hose holder or monitor nozzles.

A full-body encapsulating chemical protective suit with positive pressure SCBA may be necessary.

Personal Precautions, Protective Equipment, and Emergency Procedures

Emergency responders: use the personal protective equipment recommended in Section 8 of this safety data sheet.
